RAWSEP View: What follows is a transcript of a brief interview with the Attorney General of Vermont. A retail wood stove seller who would like to sell off his polluting wood stoves is also interviewed. The retail wood stove seller is in limbo right now because the EPA has not updated its wood stove certification standards, but are you sorry for this wood stove retailer? Did he think he was selling non-polluting wood stoves? The wood stove retailer wants clarity on whether the stoves he has in his store now are violating clean air standards, but the Office of the Attorney General (O I G) watchdog of the EPA already stated in a report in February 2023 that his wood stoves are extremely likely to be violating clean air standards. That is clarity. Who is at the table when discussing air pollution in Vermont? There are many wood burning residents in Vermont. In fact Vermont is the state with the highest percentage of residential wood burners in the United States. This is ground zero of particulate pollution from wood burning, with the attendant adverse health effects. The first people the Attorney General thinks of when considering wood burning stove certification are the owners of polluting wood stoves. The solution to the problem of owning and operating a polluting wood stove is to remove that stove from retail stores, and from people's homes. The government even provides subsidies for replacement of a wood stove with heat pumps that work at temperatures down to 40 degrees below zero Fahrenheit. Those heat pumps are so efficient they guarantee to lower any heating bills and heat pumps double as efficient air conditioners in the summer. No, the Attorney General is primarily concerned, in joining this suit against the E P A not with clean air, but with providing "clarity" to wood stove owners. It is "clear" that wood stove owners should stop wood burning, if not for their own health, for the health of their near neighbors. And how about those near neighbors? They also vote. The Attorney General thinks not of cutting emissions from wood burning but the feelings of the wood stove owners who elected her. They have polluting wood stoves. The wood stoves waiting to be sold in the retail stores are polluting. The O I G stated that in February 2023. Will wood burners' feelings be hurt if wood burning is labeled polluting, and (gasp!) not "green" in the Green Mountain State? Will wood burners' feelings be hurt if the health of their near neighbors is valued above their only recreation, sitting immobile in front of smoking solid fuel? Current wood burners could heat their homes instead with government subsidized heat pumps which would lower their heating bills and improve their health along with the health of their near neighbors. Who is at the table when the Attorney General makes decisions about how much pollution can be tolerated from wood burning in Vermont, which is the negotiation when deciding the rules of certification of wood stoves? The near neighbors of indoor residential wood burners suffer lung cancer, asthma, and cataracts directly because of neighborhood wood burners. Near neighbors of indoor residential wood burners are residents of Vermont too, and they vote too. Does everyone who moves to Vermont expect to breathe wood smoke instead of using the most modern ways to heat homes, when they could breathe clean air? There should be a complaint based system instead of certification of stoves that all agree are polluting. But wood stove manufacturers negotiate how polluting wood stoves are allowed to be, using certification. This is similar to when the tobacco companies introduced "low tar" cigarettes that caused lung cancer along with ordinary cigarettes. The lie of marketing "low tar" cigarettes as "safer" worked as a marketing gambit for the tobacco companies for a while. Then when the 2023 regulation limits are set that E P A decides, indoor residential wood burners can have clarity. Then the wood stove manufacturers can also have clarity, and certainty of just what level of pollution is allowed, so the loopholes can be set up to nullify the whole process of certification. Clarity indeed. It is clear when a PurpleAir PM2.5 monitor's data shows emission levels above E P A standards, when that PurpleAir monitor is hanging from the eaves of a home of a near neighbor of an indoor residential wood burner, it is clear that levels of particulate pollution above 25 micrograms per meter cubed daily or 8 micrograms per meter cubed annually, register on that PurpleAir PM2.5 Monitor, that "unsafe" levels of wood burning particulates are being emitted that are harmful to human health and wood burning PM2.5 is being emitted that causes early deaths of near neighbors of indoor residential wood burners. Those near neighbors should be able to complain to Health Departments, and those Health Departments should be able to shut down indoor residential wood burning, wood stove by wood stove if necessary, without even having to enter the residences of wood burners, but armed with scientific proof of evidence of real, real-time harm to public health caused by wood stoves. Near neighbors should not have to be canaries in a coal mine, since the health effects of wood smoke have been demonstrated on the East Coast from Canadian wildfire smoke repeatedly and dramatically in the last few months. This primitive and obsolete method of home heating, indoor residential wood burning, in wood stoves or any other wood burning appliance, needs to be retired, since there are clean, and now cheap alternatives in 2023.

Attorneys General of 10 states, including Vermont, are Intending to sue the EPA over wood stove standards. In their letter to the EPA, the state's attorneys general accused the agency of not keeping up with mandatory duties. Channel 3 explains. New at six.

The Environmental Protection Agency's Office of Inspector General released a report back in February saying their 2015 performance standards for wood stoves were flawed and lacked clarity. Those standards were supposed to receive an update earlier this year, but that never happened.

(Charity Rae Clark speaking) There are no systems in place for certifying or testing these wood stoves.

In a notice of intent to sue, 10 states allege the EPA is not taking steps to protect public health or the environment under current EPA rules. Stoves are being tested and certified by third party labs using different methods.

(Charity Rae Clark speaking) Right now we have a regulation that they haven't followed. It expired in May or was due in May. Every eight years, they're supposed to review those performance standards. They have not reviewed those performance standards.

(Owner of the retail store at Montpelier Stove and Flag, Ray Flaggy, explains) wood stoves are supposed to emit less than two grams of particulates per hour. He says unless that number changes, updating the standards would mostly impact manufacturers.

(Ray Flaggy speaking) Assuming that they do change the standard, some of the product might not meet that standard. Hopefully we'd have some time to sell them off.

It's also been pointed out a lot of money has been spent by the state and individuals to upgrade to systems meeting EPA standards.

(Charity Rae Clark speaking) Vermonters deserve to get what they're paying for, and that means making sure that these wood stoves are as good as they say they are Clark says.

(The reporter speaking) The EPA has not provided a formal response to their notice of intent to sue. They also did not return my request for comment. Clark says if they don't review these performance standards by the end of August, that's when they'll be. Filing the suit. In The Newsroom, Channel 3 News.

She then enrolled at Boston College Law School, earning her Juris Doctor degree in 2005. In 2014, William Sorrell, then the attorney general of Vermont, hired Clark as an assistant attorney general. She served as the chief of staff to T. J. Donovan for four years while Donovan served as attorney general. Clark announced her candidacy for state attorney general in the 2022 Vermont Attorney General election, as Donovan was not seeking reelection. Clark defeated Rory Thibault, the states attorney for Washington County, in the Democratic Party primary election, 58% to 28%. In the November 8 general election, she faced Republican Mike Tagliavia, a first-time candidate who is not an attorney, and

won the election with 65% of the vote, becoming the first woman ever elected Attorney General of Vermont. RAWWEP View: What about neighbors of wood stove owners???? As of January 5, 2023, Charity Clark is the Vermont attorney general, having been elected in 2022. The office provides legal counsel for all state agencies and the Vermont General Assembly, the state's legislative branch. Vermont and New York are among 10 states intending to sue the EPA over wood stove standards. In a letter to the EPA last week, the states accuse the agency of failing to review and ensure emissions standards by allowing the continued sale of appliances that could worsen pollution.

The proposal is a new rule in New York targeting coal and wood-fired ovens.

The story quickly went viral.

On Twitter Elon Musk called the proposed requirement "utter BS" in a response. Dave Portnoy, of Barstool Sports, tweeted a video. In an interview with Fox News in an NYC pizzeria, Republican presidential candidate and Florida Governor Ron DeSantis blamed the proposal on the political left, stating, "They just don't want people to be happy." The proposal instead aims to reduce "particulate matter emissions," which are bad for humans to breathe in. When pizza ovens are fired up, the burning of fuels like wood or coal creates this airborne pollution. As the EPA explains, this type of pollution is "a mixture of solid particles and liquid droplets ... such as dust, dirt, soot, or smoke." Coal- and wood-fired ovens release significant amounts of particulate matter. This has been linked to serious health problems like asthma,

heart and lung problems, and <u>cancer</u>. The NYC proposal would <u>require</u> that any pizzeria using coal- or wood-fired ovens (that were installed before May 6, 2016) add an emission control device, if possible, to cut particulate pollution by 75%. Texas, Houston, Drax

RAWSEP View: The writer begins this article stating "The practice of burning wood for energy generation has seemed like an anachronism in the 21st century to many, including, frankly, myself. After all, one of the main reasons why England shifted to burning coal for cooking and heating purposes beginning in the 16th century was due to the rampant depletion of the country's forests, to such an extent that wood for fuel had actually become a scarce resource." What makes this writer change his mind, and decide wood fuel is the wave of the future? Not because wood burning is clean energy, but because Drax is a big, successful company, and to him, Drax rules. "Drax, a renewable energy company based in the United Kingdom, has been engaged for decades in the manufacture and supply of wood pellets for use in biomass power generation for customers in Europe and Asia. While Drax has also maintained operations in the United States for years, the company recently announced the establishment of U.S. headquarters in Houston, Texas, from which it will manage plans to expand operations into the Southeastern United States."

The writer makes some errors in fact, such as stating 1)wood burning is cleaner than coal burning, which is untrue, and 2)To control pollution, Drax plans to use a carbon capture system. But CCUS, carbon capture systems are expensive and have never worked. Wood burning emits more PM2.5 and CO2 than coal burning and carbon capture has never worked in an industrial facility and requires government subsidies to pay for the ongoing decades long failed attempts at carbon capture. Carbon capture is taxpayer dollars for the cleanup of emissions. It doesn't work, doesn't work for biomass plant emissions, as it doesn't work for coal plant emissions. This article is about grabbing money from the Inflation Reduction Act to subsidize an industry that cannot pay for itself, and grabbing money for wood burning that perpetuates emissions worse than coal burning emissions.

SEATTLE — Unhealthy air quality resulting from wildfires can have adverse effects on people with health conditions like asthma and pulmonary disease, but what is less clear is how long-term exposure to smoky air impacts the health of the general public. "Everything you see in the literature is calling for more research into this," said a <u>cardiologist</u> at Swedish Medical Center.

The doctor specializes in treating heart failure and said he notices when the Seattle area experiences hazy skies from wildfire smoke. "We definitely do see higher levels of heart attacks at that time," The doctor said. Unhealthy air does not only affect the lungs; it can be dangerous for the cardiovascular system. For people with existing pulmonary disease, significant exposure to smoky air can lead to heart failure and stroke. "You have both chemical and fine-matter particles that get all the way down into the deepest areas of our lung and they can sit there, and cause oxidative stress," the doctor said. Those, along with coughing and difficulty breathing are some of the short-term impacts for people with health issues. But what is less clear is what a persistent, seasonal onset of wildfire smoke does to healthy individuals in the long run. A climate adaptation strategist with Public Health -- Seattle & King County, said more research needs to be done. "We don't have a complete picture of exactly how well wildfire smoke will impact our health but we are seeing a lot more evidence suggesting that people who consider themselves to be young and healthy, may actually be at higher risk than they previously perceived to be,", the climate specialist said.

The second doctor said the focus should be understanding the very small particles present in wildfire smoke that measure smaller than PM 2.5. "Which is very fine particulate matter that has a diameter of about 20 times narrower than the width of a human hair," the climate specialist said. Wildfire smoke particles can include chemicals, carbon monoxide, nitrogen oxide, and other volatile, organic compounds. "All these things can cause free radical damage to the DNA", the doctor said. "This is at least what we know about smoking." The doctor said that could lead to worsened lung function, but agrees that more research needs to look at which particles from smoke could lead to long-term impacts. "If there is a particular particulate matter that we could determine is the biggest offender, that's something, but there are very sparse amounts of data about that," The doctor said. The climate specialist advises people to avoid spending prolonged time outside when the air quality is bad and to wear a quality mask like an N95 or K95 if going outdoors is a must. It is also recommended people install MERV filters in their homes to filter out any harmful particles.

The city's air quality has improved since early morning but is still not good for sensitive groups. Africa's energy poverty: Push to renewables, more players for power supply may help Madagascar's electrification plans Around 35% of country has access to electricity, 1.4% has access to clean cooking fuel July 10, 2023.

Madagascar, officially the Republic of Madagascar, is an <u>island country</u> lying off the southeastern coast of <u>Africa</u>. It is the world's <u>fourth largest island</u>, the <u>second-largest island country</u> and the 46th largest country in the world. Its capital and largest city is <u>Antananarivo</u>.

Solar kits are extremely popular in rural areas of Madagascar and over 50,000 kits have been sold so far. Madagascar is one of the world's most energy-starved countries. The government plans to democratise electricity access, to bridge the energy gap in the country. 35 per cent of Madagascar's population has access to electricity and 1.4 per cent has access to clean cooking fuel, according to intergovernmental organisation International Energy Agency. The country mainly depends on biomass for cooking fuel. A visit to Ambohimanatrika village in Moramanga district on June 11, 2023, showed the dismal state of their energy economics. Two women and two children returned to the village with bundles of dry twigs on their heads. The fuel doesn't last long and in a couple of days, the villagers have to go in search of more firewood for cooking. The country is running out of forests. Locals reported having to travel longer and farther in search for wood and even having to chop down trees despite knowing its effects. Collecting firewood or substitutes is permanent work though the year for many. Charcoal (wood burned until it is reduced to almost pure carbon, which burns longer and hotter) is a necessity in towns too, as access to cooking gas, a luxury priced at \$2 a kilo because of monopoly, is limited. In a year a household only uses about 400 grams of cooking gas on average. A poor household spends about one-third of its revenue on fuel for cooking. Fuelwood constitutes 92 per cent of the national energy offer compared with seven per cent for gas products and only a per cent for renewable, according to Madagascar's New Energy Policy (NEP). Ironically, the island is endowed with huge potentials: 7,800 megawatts of hydroelectricity with only 165 megawatts exploited in 2018; 1,500-2,100 kilowatt hour per square metre per year of solar radiation and 7-9 metres per second for wind turbines at 50-metre height at the southern and northern tips of the island nation. Because of its high reliance on biomass, Madagascar has a non-sustainable management mode for its wood capital. The country's wood stocks have significantly decreased since 2012, the World Bank pointed out. The country's forest cover is less than 10 per cent today, while the island might lose it completely by 2100. "Reliance on biomass is another leading driver of deforestation. The high dependence of much of the population on fuelwood for cooking causes degradation, and has severe health and productivity impacts, particularly on women and children," reads the World Bank's Country Environmental Analysis 2022. It also stressed that air pollution, largely indoors, is the third largest risk factor for death and disability in Madagascar. The economic cost of land degradation since 2000 is estimated at over \$6.7 billion amounting to 1.78 per cent of gross domestic product per year. The Institute for Health Metrics and Evaluation, an independent global health research centre in Washington, estimated nearly 21,500 deaths and 912,000 days lost to illnesses annually in Madagascar. Madagascar is fast promoting renewable energy. In 2023, the government promised to set up solar parks with 2 megawatts of installed power in 42 districts and 32 are promised for next year. Malagasy Energy and Hydrocarbons Minister Solo Andriamanampisoa said "The country has around 5.8 million households. Only nearly 600,000 of them access electricity and the rest need solutions like the development of renewable projects by boosting rural electrification," . The electricity sector needs total reform. Thus, the government aims at totally abandoning fossil fuels amidst the climate change goals despite the low rate emissions in the country, strengthening the national supply capacity, and reinforcing the National Regulatory Authority and the Rural Electrification Development Agency (ADER). So far, the state-controlled water and electricity company Jirama holds the electricity sale monopoly, according to the law. But users criticize bad service and frequent power outages throughout the year. On June 9, 2023, the WB Group Board of Directors approved \$100 million in credit. Yet another \$400 million is awaited from the Bank too. The rural electrification market in the island is a big opportunity: charging mobile phones has emerged as a major local business, showing the need for electrification in rural areas, said the head of strategy and operations SHS at MBalik Telma company, which is affiliated to the mobile phone and network company Telma. Solar kits are extremely popular in the countryside, similar to a few other African countries, and more than 50,000 kits have sold to 250,000 residents so far. Investors should look into Madagascar's renewable market. However, the initial costs are steep. But the minister pointed out fiscal advantages: renewable equipment has no import duties in the country and higher investment will bring down prices soon. President Andry Rajoelina had earlier promised the construction of a factory dedicated to the

production of solar panels for the Malagasy use. The implementation is still awaited even as there are a few months left till the next election. 'It's Time Africa Switched'
