11)The Maine Attorney General is a Democrat, Aaron Frey.

Aaron M. Frey (born c. 1978) is an American lawyer and politician serving as the 58th Attorney General of Maine since 2019. He formerly served as a Democratic representative in the Maine House of Representatives. He is currently being investigated by his own party for a sexual relationship with a married direct subordinate as well as his handling of disclosure. Frey was born and raised in Dixmont, Maine. Frey attended Saint Anselm College, and graduated from Saint Anselm with a Bachelor's degree in politics, and later received a Juris Doctor degree from Roger Williams University School of Law. He later started a law firm in Bangor. In 2012 he was elected to the Maine House of Representatives. From December 2014 until his resignation, he represented the 124th district, which includes parts of Bangor and Orono. In December 2018, Democrats in the Maine Legislature chose Frey as their nominee for Maine Attorney General. He succeeded Janet Mills as Maine Attorney General, and Janet Mills was elected Governor of Maine. Upon taking office, Frey stated that he would consider involving Maine in multi-state lawsuits against pharmaceutical companies. He later joined a lawsuit accusing drug manufacturers of price inflation. In February 2019, Frey became one of sixteen state attorneys general to join a lawsuit against the Trump administration over President Trump's decision to declare a national emergency. The emergency declaration was made to allow the President to allocate funding for a wall on the United States-Mexico border. In April 2023, Frey announced that he was in a romantic relationship with an employee under his direct supervision in the Attorney General's Office and called it "an error in judgment" to not reassign the employee to a new supervisor. In an email to office staff, Frey identified the employee as an Assistant Attorney General and disclosed that the relationship had begun in August 2022. The revelation was made after the Bangor Daily News began investigating tips about Frey's relationship.

His district covered most of the majority-black precincts in <u>Prince George's County</u>, as well as a sliver of <u>Anne Arundel</u> <u>County</u>. He was elected to the lieutenant governorship in 2006 on the Democratic ticket with <u>Governor Martin O'Malley</u>; both were re-elected in 2010. In 2014, Brown ran unsuccessfully for the governorship. In October 2021, Brown announced that he would not seek reelection to the U.S. House in 2022 and would instead <u>run</u> for <u>attorney general of</u> <u>Maryland</u>. won the general election on November 8, 2022, becoming Maryland's first Black attorney general. He is a retired <u>colonel</u> in the <u>United States Army Reserve</u>, having served in the U.S. Army for over thirty years. While lieutenant governor, Brown was the highest-ranking elected official in the nation to have served a tour of duty in Iraq. 4b) The Massachusetts Attorney General is a Democrat, Andrea Campbell.

Andrea Joy Campbell (born June 11, 1982) is an American lawyer and politician who is serving as the <u>attorney</u> <u>general</u> of <u>Massachusetts</u>. She is also a former member of the <u>Boston City Council</u>. In 2022, Campbell was elected to serve as the <u>attorney general of Massachusetts</u>. Campbell was the first black woman to qualify for the ballot in a statewide election in Massachusetts . Campbell won the general election by a large margin. In January 2023, she was sworn-in as attorney general, becoming the first black woman to hold the office and only the second black person to hold it, preceded only by <u>Edward Brooke</u>. Campbell is regarded to be a political <u>progressive</u>. Campbell and her siblings spent much of their childhood in <u>foster care</u> and living with a variety of relatives after their father was given an eight-year prison sentence and their mother was killed in a <u>car accident</u> shortly after Campbell's birth. While Campbell found a path to attend <u>Princeton University</u> and find political success, her two brother's both found themselves spending time in prison, with twin brother dying in state custody at the age of 29.

5)The Minnesota Attorney General is a Democratic-Farmer-Labor Party (DFL), which opposes Republican candidates. Keith Maurice Ellison (born August 4, 1963) is an American politician and lawyer serving as the <u>attorney</u> general of <u>Minnesota</u>. Ellison was the <u>U.S. representative</u> for <u>Minnesota's 5th congressional district</u> from 2007 to 2019. In Congress, Ellison built a reputation as a <u>progressive</u> leader. Born and raised in <u>Detroit, Michigan</u>, Ellison moved to Minnesota for law school. In the U S Congress, Ellison's district included <u>Minneapolis</u>, the state's largest city, and its inner-ring suburbs. In Congress, Ellison was a vice-chair of the <u>Congressional Progressive Caucus</u>. He also sat on the <u>House Committee on Financial Services</u>. Ellison was the first <u>Muslim</u> elected to <u>Congress</u> and the first <u>African</u> <u>American</u> representative from <u>Minnesota</u>. After his successful <u>run for Minnesota attorney general</u> Ellison became the first African American elected to partisan statewide office in <u>Minnesota</u>, as well as the first Muslim in the U.S. to win statewide office. He was reelected in <u>2022</u>.

6)The New Jersey Attorney General is a Democrat, Matthew Platkin.

Matthew J. Platkin (born in 1986 or 1987) is an American attorney serving as the <u>Attorney General</u> of the State of <u>New</u> <u>Jersey</u>. A resident of <u>Montclair</u>, <u>New Jersey</u>, Platkin was raised in <u>Florham Park</u>, <u>New Jersey</u> and <u>Morristown</u>, <u>New Jersey</u>. He earned his undergraduate degree from <u>Stanford University</u> and earned a <u>Juris Doctor</u> from <u>Stanford Law School</u>. He started his career with the <u>Brookings Institution</u>, advising Congress on economic recovery after the <u>2008 financial crisis</u>. Platkin served as Chief Counsel to Governor Murphy from January 2018 to October 2020. During the <u>COVID-19</u> pandemic, he drafted executive orders and workforce policies for state government employees. He took a leave during January 2020 to serve as Senator <u>Cory Booker</u>'s special counsel during the <u>first impeachment of Donald Trump</u>. On February 3, 2022, Governor <u>Phil Murphy</u> announced that he was appointing Platkin to serve as Acting Attorney General. Platkin assumed office on February 14, 2022, succeeding <u>Andrew Bruck</u> as Acting Attorney General. He assumed the position in full on September 29, 2022, after the confirmation of his appointment by the New Jersey State Senate.

7) The New York Attorney General is a Democrat, Letitia James.

Letitia Ann James (born October 18, 1958) is an American lawyer and politician. She is the current <u>Attorney General of New York</u> (NYAG), having won the <u>2018 election</u>. James is the first <u>African American</u> and first woman to be elected to the position. Born and raised in <u>Brooklyn</u>, James graduated from <u>Lehman College</u> in <u>The Bronx</u> before obtaining her <u>Juris</u> <u>Doctor</u> degree at <u>Howard University</u> in <u>Washington</u>, D.C. She worked as a <u>public defender</u>, then on staff in the <u>New York</u> <u>State Assembly</u>. James served as a member of the <u>New York City Council</u> from 2004 to 2013. She represented the <u>35th</u> <u>district</u>, which includes the Brooklyn neighborhoods of <u>Clinton Hill</u>, <u>Fort Greene</u>, parts of <u>Crown Heights</u>, <u>Prospect</u> <u>Heights</u>, and <u>Bedford–Stuyvesant</u>. James chaired the committees on economic development and sanitation. From 2013 to 2018, she was the <u>New York City Public Advocate</u>, making her the first African-American woman to be elected to and hold citywide office in New York City.

8) The Oregon Attorney General is a Democrat, Ellen F. Rosenblum.

Ellen F. Rosenblum (born January 6, 1951) is an American lawyer and politician who has served as the Oregon Attorney General since 2012. She is the first female state attorney general in Oregon's history. Rosenblum was born in Berkeley, California. The family moved to Evanston, Illinois. Ellen Rosenblum attended Scripps College before earning her undergraduate degree from the University of Oregon in 1971, where she also earned a J.D. degree in 1975. In 1975, Rosenblum became an associate at a Eugene Oregon law firm and later became a partner. In 1980, she became an Assistant U.S. Attorney for the District of Oregon, specializing in financial crimes. Rosenblum retired as a judge in May 2011. In January 2012 Rosenblum started her campaign for the Democratic nomination for Oregon Attorney General. Her Democratic primary opponent criticized the Oregon Medical Marijuana Act, and Rosenblum gained the support of Oregon marijuana legalization supporters by pledging to "make marijuana enforcement a low priority, and protect the rights of medical marijuana patients." In the May Democratic primary, she went on to defeated her opponent by nearly 30 percentage points to move on to the general election. In 2012, then Oregon Attorney General Kroger announced his resignation effective June 29, 2012 to become President of Reed College, and Governor John Kitzhaber named Rosenblum to replace Kroger effective that same day. Rosenblum became Oregon's first female Attorney General. She served in the appointed position until January and won the general election in November for a full term. Rosenblum was re-elected to another term as Attorney General in November 2016, In July 2020, Rosenblum filed a lawsuit against the federal government, accusing it of unlawfully detaining protesters, after footage emerged of agents in unmarked vehicles (but not unmarked police officers) appearing to forcefully seize protesters.

9)The Vermont Attorney General is a Democrat, Charity Rae Clark, who was profiled briefly in Episode 56FY. Charity Rae Clark was born in <u>Springfield</u>, <u>Vermont</u> on July 15, 1975. She was raised in <u>Manchester</u>, <u>Vermont</u> and resides in <u>Williston</u>, <u>Vermont</u>. She earned her <u>Bachelor of Arts</u> degree in <u>political science</u> from the <u>University of Vermont</u> in 1997 and served as a policy analyst in the administration of Governor <u>Howard Dean</u>. She then enrolled at <u>Boston College</u> <u>Law School</u>, earning her <u>Juris Doctor</u> degree in 2005. In 2014, the then attorney general of Vermont hired Clark as an assistant attorney general. Clark announced her candidacy for state attorney general in the <u>2022 Vermont Attorney</u> <u>General election</u>, and Clark won the Democratic Party primary election, 58% to 28%. In the November 8 general election, she won with 65% of the vote, becoming the first woman ever elected Attorney General of Vermont. 10)The Washington Attorney General is a Democrat, Robert W. Ferguson.

Robert Watson Ferguson (born February 23, 1965) is an American lawyer and politician serving as the <u>attorney general</u> <u>of Washington</u>. He was first elected in <u>2012</u>. Prior to serving as Attorney General, Ferguson was a member of the <u>King</u>

County Council. On May 2, 2023, Ferguson declared the formation of an exploratory committee, a move widely considered to indicate he will run for governor in the 2024 Washington Gubernatorial Election. Ferguson was born in Seattle in 1965, attended the University of Washington,. After college, Ferguson joined Jesuit Volunteer Corps Northwest and directed an emergency services office for a year. Ferguson earned a Juris Doctor from the New York University School of Law. During law school, he received a grant to provide legal assistance to the Yaqui tribe in Guadalupe, Arizona. Ferguson began his legal career in Spokane, where he served as a law clerk for Chief Judge William Fremming Nielsen of the Federal District Court for Eastern Washington, who was appointed by George H. W. Bush. He then clerked for Judge Myron Bright of the 8th Circuit Court of Appeals in the Midwest, who was appointed by Lyndon Johnson. After his clerkship, he became a litigator, in a Washington Special Assistant Attorney General law firm, where he represented individuals, businesses, local governments, and Washington corporations. As an attorney, Ferguson worked with the legal team that successfully defended taxpayers from paying for cost overruns associated with Safeco Field construction. Ferguson worked on cases involving software piracy and successfully sued companies that stole intellectual property from Washington companies. Ferguson was first elected to the King County Council in 2003. During his campaign Ferguson knocked on 22,000 doors in the district. served on the King County Council, where he represented Council District 1, which includes northeast Seattle, Shoreline, Lake Forest Park, Kenmore, Bothell, Kirkland, and part of Woodinville. In 2006, he helped lead the effort to create permanent oversight in the King County Sheriff's office. He sponsored the Open Space Preservation Act, which protects 100,000 acres of open space. [22] Ferguson authored legislation that prevents King County from doing business with companies known to repeatedly violate wage theft laws. He co-sponsored legislation promoting the use of small businesses in Accelerator" program. He declined to take a pay raise during tough economic times. Ferguson also helped lead the effort

fulfilling county contracts. (Ordinance 2007-0146). Ferguson co-sponsored legislation in 2011 creating a "Small Business for an independent audit of the county's election office. He wrote the law that reformed the county's public records process to ensure that citizens can easily obtain records and monitor their government. In 2012, Bob Ferguson was elected as the Attorney General of Washington State. Ferguson received 53.48% of the vote. During the campaign, Ferguson visited all 39 Washington state counties. In 2016, Ferguson was re-elected, 67% to 33%. He carried 37 of the state's 39 counties. In 2020, Ferguson faced a strong Trump supporter, who said that Ferguson was too soft on crime and criticized his legal challenges of the Trump administration. Ferguson handily won reelection, 56% to 43%. Ferguson sued the Trump administration 97 times, leading 36 of the cases, realizing victory 22 times, and losing once.

COLOMA, Wis. - The Wisconsin Department of Natural Resources (DNR) fire crews and local agencies are on the scene of the now roughly 830-acre Pallet Fire in Waushara County, southeast of Coloma. The fire is 99% contained. Three primary structures and 17 secondary structures have been lost. The cause of the wildfire is debris burning. Previous reports have stated various sizes; the update to 830 acres is based on the use of infrared/satellite technology and location points taken on the ground used to help get a more accurate depiction of the size of the fire. The fire size will be updated as more information is available. Officials say the Pallet Fire travelled northeast and burned in pine and mixed hardwoods along Cumberland Avenue and north of Hwy 21. Fire officials on scene indicated erratic fire behavior due to gusty winds and drought conditions, along with reports of torching with fire moving into the crowns of the trees. Several spot fires occurred ahead of the fire and were suppressed and monitored. DNR fire suppression resources and local fire departments are on the scene, continuing suppression efforts and providing structure protection. Eight firefighters have been treated for injuries and released. DNR Incident Management Team staff continue to operate at the command post located at the Coloma Fire Department. Waushara County Emergency Management and local law enforcement agencies are also on the scene. Alliant Energy is working to restore power in the area. Almost no rain was received in the fire perimeter overnight, so fire conditions remain active today. Drought, warm temperatures and low relative humidity are still forecasted, but winds are expected to be lighter today. Fire danger remains high across many parts of the state due to these conditions. Campfires, ashes from fireplaces, outdoor grills, smoking, chainsaws, off-road vehicles or other small engines have the potential to throw a spark, ignite a fire and spread quickly. Please use extreme caution and avoid burning until conditions improve.

This brain works for the forestry industry, go figure. And this pollution will be directed at a senior living facility. To cover the high cost of new technology , included is a \$1 million U.S. Forest Service grant for New London Place, to support this outlet for the logging industry. To make financial sense when burning wood for a large housing development, I have recently learned, you need to do something that sounds kind of crazy: Use it to cool yourself.

"That's the key. ... District heating with wood is not a new thing, it's use of heat energy to power air conditioning in the summertime that makes it work," said an energy and forestry consultant who has been around the state's timber industry for a long time.

Excerpts edited by RAWSEP for brevity and clarity and relationship to Residents Against Wood Smoke Emission Particulates.

I was picking the forestry consultant's brain about two upcoming developments: New London Place, a quarter-millionsquare-foot senior living complex that should open in New London in 2025, and Ridgeline Community in Conway, where ground was broken in March. They hold promise for using biomass energy in large developments without destroying the environment or investors' savings, something that forest-filled New Hampshire would like to see more of. Both will have centralized systems that burn wood chips for a multitude of buildings – 44 one-bedroom cottages and a 106-unit assisted living facility in Ridgeline's case, and 12 cottages plus a facility with 96 apartments and 60 assistedliving units in New London Place. This kind of district system is old hat but these will be the first in the state to have "combined heat and power" or CHP systems, right on sight. That's compared to biomass boilers providing only heat, as was done by the former Concord Steam, or only electricity, as is done by the state's wood-burning power plants. Both of those systems have struggled financially, with <u>Concord Steam</u> shutting in 2017 after 79 years and the power plants struggling to stay open without government support. Concord Steam's problem was that its income fell when temperatures rose, while the power plants' problem is that they waste a lot of the energy from burning wood, sending excess heat into the air. Doing both allows for more efficiency and more financial stability. "Getting a 12-month load on the boiler, that allows you to make electricity and do so at high efficiencies," he said. The systems will provide a portion of the electricity used by the developments, which will still be tied to the grid. The forestry consultant recently gave a presentation to Clean Energy New Hampshire on new and improved technologies that are making combined heat and power feasible at this scale like gassification, organic Rankin cycle and liquid salt for heat exchange. RAWSEP View: These expensive technologies sound like expensive and failed experiments in carbon capture of the past.






