RAWSEP View: In Independence Township, Michigan, no permits are now required for open burning, but now a doctor's note for a complaining near neighbor is required to stop polluting open burning. Since any amount of PM2.5 is harmful to human health, according to the World Health Organization, a doctor's note should not be required. A near neighbor should not have to develop asthma or lung cancer before a near neighbor can make a complaint about PM2.5 entering their yards and infiltrating their homes from a wood burner's smoke. Revision to open burning ordinance September 6, 2023. There has been a change to the open burn ordinance in Independence Township. At the Aug. 8 regular meeting of the Independence Township Board of Trustees, approval was given to eliminate the requirements to obtain a burn permit for open burning on residential property. "All rules stay in place in relation to days and hours allowed per the burn calendar and what can be burned," said Township Fire Marshal Greg Brandt. "We are constantly looking for ways to improve inefficiencies and one of those ways is in this permitting process. Getting this permit was inconvenient to residents and used valuable time for fire department staff. It is important to note that the fire department will still respond to calls about open burning in the same way they did before the permit requirement was dropped." Open burning is allowed from April 1 through Nov. 30, 8 a.m.-8 p.m. and Dec. 1 through March 31, 8 a.m.-6 p.m. All fires must be completely extinguished after hours (no smoldering). Parcels of less than three acres must follow the burn date calendar, while parcels larger than three acres may burn any day. Regardless of acreage, weather – particularly wind – should be considered prior to burning to prevent fire spread and smoke. Burn dates for the rest of 2023 are Sept. 7, 16, 17, 19, 21, Oct. 1, 3, 5, 7, 15, 17, 19, 21, Nov. 2, 4, 5, 7, 16, 18, 19, 21, and Dec. 2, 3, 5, 7, 16, 17, 19, 21. Other rules to follow: All materials being burned must be from the site. No materials may be brought to the site for disposal. Open burning shall be constantly attended by a person 14 years of age or older until the fire is extinguished. A source of extinguishment shall be present and adequate during hours of burning. No burning shall be permitted within 50 feet of any structure. Provisions shall be made to prevent the fire from spreading. No burning along roadways. No flammable liquids shall be permitted to ignite the fire (i.e. gasoline, kerosene, starter fluid, etc.). No burning shall be allowed on construction sites. The size of the pile to be burned shall be no larger than six feet in diameter. Burning violations may be subject to fines in accordance to civil infraction penalty, and privileges revoked. Acceptable burn items include dry leaves, paper, brush, and wood scraps. The Independence Fire Department has the right to extinguish any fire deemed by fire department personnel to be a hazard or nuisance. In addition, recreational burning is defined as the burning of seasoned wood in a manufactured device, specifically designed for the containment of the fire, with the intent of using the fire for cooking or social purposes. A container designed for recreational burning must be used. Materials to be burned shall be consistent with firewood, or other seasoned hard wood. All recreational fires must be tended to and extinguished completely when finished. It is also the policy of Independence Township to prohibit open burning within 400 feet of any residence whose occupants have a documented serious medical condition that is aggravated or triggered by the exposure to smoke from open burning, unless allowed under the provisions of this policy. Residents are required to submit documentation from a medical doctor to the fire department supporting the diagnosis of a medical condition that is serious and aggravated or triggered by exposure to smoke from open burning. City Hall chiefs have admitted that people using log burners in Bristol are unlikely to be fined as the new policy is a "bit of a joke". Bristol City Council has been given new powers to issue £300 fines but does not have the funding to enforce the new stricter rules. Burning wood emits harmful pollution known as fine particulate matter, or PM2.5, which can cause serious health problems. Cabinet members approved new powers to issue fines to anyone caught using non-compliant stoves or fuels, but admitted the policy has "no teeth".

The frank admission raises doubts that anybody will actually be caught or fined under the new rules, which are intended to reduce pollution levels and improve air quality. The Labour cabinet signed off the new policy during a meeting on Tuesday, September 5. Councillor Kye Dudd, cabinet member for climate, said: "From a public health point of view, there's no safe level of particulate matter. If you're concerned about health then the advice is don't burn wood at home. "But if you're going to do that, you have the legal right to do it, within the regulations. make sure you've got a Defracompliant stove, and compliant fuels." Councils in England were given new powers by the government about a year ago. In theory, council staff can now issue written warnings and then fines to anybody caught burning wood or using a stove that isn't on a list of government-approved fuels and appliances. But Bristol City Council has not been given any extra funding to enforce the new powers, and will instead rely on neighbours to complain if they see a lot of smoke coming from nearby chimneys. Councillors also questioned how they were supposed to act on complaints. Councillor Nicola Beech added: "The policy hasn't really got any teeth because of the lack of funding. This is a real public health issue. "As we see the cost of living crisis hit more, we know people are using inappropriate means to heat and power their homes because they can't afford any alternative." A letter sent on 8/28/2023 to the Assistant Attorney Generals threatening to sue the EPA over wood stove certification follows.

Dear Assistant Attorney General,

Attached is a letter that was sent to the National Institute of Allergy and Infectious Diseases (NIAID) Director Dr. Jeanne Marrazzo, former acting NIAID Director Dr. Hugh Auchincloss and National Institutes of Health (NIH) Director Dr.

Lawrence Tabak regarding regulation and the ability to shutdown PM2.5 polluting indoor residential wood burners.

PM2.5 pollution is known to cause antibiotic resistance making infectious disease pandemics more likely and uncontrollable.

The letter asks Dr. Marrazzo to apply a "Parallel Track" to indoor residential wood burning pollution in 2023. This "Parallel Track" would include both EPA wood stove certification and a complaint-based system using PurpleAir PM2.5

monitor data collected from the yards of near neighbors of indoor residential wood burners. This would be a way to address the very real impact of PM2.5 pollution which EPA wood stove certification fails to address. We propose that the use of PurpleAir monitors would provide important data on PM2.5 air pollution that is currently missing in the EPA wood stove certification.

This proposal is modeled on the approach Dr. Anthony Fauci used in 1989 that allowed a "Parallel Track" of both the Food and Drug Administration (FDA) use of AZT for AIDS that had the unfortunate side effect of blindness along with a second drug, Ganciclovir, that actually cured the blindness.

An earlier letter sent to your office asked that you include a complaint-based system of regulating indoor residential wood burning using PurpleAir PM2.5 data in your suit against the EPA. Indoor residential wood burners are already ineffectively certified by the EPA. This violates the EPA's own National Ambient Air Quality Standards (NAAQS) emission limits of 35 micrograms per cubic meter in a 24-hour period. Using data from PurpleAir PM2.5 monitors in the yards of near neighbors who complain of PM2.5 from hyper-localized indoor residential wood burners would provide the missing and important evidence of this type of air pollution.

Currently if a near neighbor's complaint is made to a local health department, a complaint using federal NAAQS exceedance data is not considered as a basis for a complaint against neighboring indoor residential wood burning. It is also not considered as a basis for shutting down the wood burning appliance when the indoor residential wood stove has been federally EPA certified. Lawsuits for nuisance are expensive and beyond the means of the average American and are not considered precedents in courts generally. Contacting state agencies to shut down polluting wood stove use that affects the health and lives of near neighbors has been unproductive because decisions made by the EPA determine the decisions made by state agencies.

Although the scope of your lawsuit seems confined to asking the EPA to continue their wood stove certification program as is, albeit at a faster pace, we ask that you consider the intent behind asking the EPA to tighten their standards for wood stove certification on a regular basis. The intent of an Environmental Protection Agency is to protect the environment. This has perhaps been narrowly construed to be protecting air, water and ground from contamination from industries only. But United States citizens should actually benefit from this environmental protection as well. Tightening wood stove standards on a regular basis should result in protecting the environment as well as protecting United States citizens from harm from the air, water, and ground. We believe that the EPA's responsibilities are inextricably connected with public health responsibilities of other government agencies such as NIAID.

Please try to accomplish something meaningful for the American people with this lawsuit by considering using a Parallel Track to include PM2.5 data in future decisions about air quality standards. Although I am not your constituent, by commencing to sue a federal agency you are representing me as a citizen of the United States and in that sense as your constituent. Thank you, Sent to
