A fella, pronounced felon, burns wood indoors residentially 60 feet from the victim's house. He lures the victim to a window with a mystifying dark and large cloud of wood smoke he had used to scare her on previous nights. Once she stuck her head out to investigate, the PM2.5 wood smoke pollution dropped on her and entered the room itself. She fell back and died from the cumulative effects of wood smoke pollution and the window slammed shut on its own. Her air purifier worked and by the time police investigated, the wood smoke had been cleared by the air purifier. Wood burning was purportedly discovered by cave men many years B C E. Wood burning for home heating is now unnecessary because wood burning has since been replaced by clean home heating methods available in 2024 even to the indigent (with 2024 Heat Pump government rebates up to \$8,000 based on a sliding income scale), such as Heat Pumps that work down to 40 degrees below zero, powered by an electric grid extending to all rural areas, powered by the clean energy sources of wind and solar energy. This tragedy might have been averted if a non-profit organization such as Friends of the Earth Oxford (a name the grimly named Residents Against Wood Smoke Emission Particulates wished they had thought of first) had handed out a PurpleAir PM2.5 monitor to the victim, so that the victim would not have acted like a "canary in a coal mine" and the victim near neighbor could have instead used the PM2.5 monitor hanging from the eaves of the victim near neighbor's house to gather, download, and show data to Health authorities that proved that the PM2.5 emitted from her fella's (pronounced felon's) indoor residential wood burner was above National Ambient Air Quality (NAAQS) standards set by the Environmental Protection Agency (E P A) (12 micrograms per cubic meter annually or 35 micrograms per cubic meter in a 24 hour period) in the victim's yard which infiltrated her home, especially when windows and doors were opened under duress, even in a house sealed against infiltration of air pollution such as PM2.5, 3)To recycle more RAWSEP day old news, Friends of the Earth Oxford want more small (PM2.5) monitors in Oxford, United Kingdom.
