Moving on to RAWSEP analysis of news and analysis of articles. 1)is an update of a 1909 suffrage poster, featuring Kewties, for 2024, 115 years later, saying “Give Mother clean air, we need it. Our food, our health, our play, our homes, our schools, our work, are ruled by PM2.5 wood smoke. Isn’t it a funny thing that a wood burner can’t see, why Mother ought to have an airing on how these things should be? Think it over” say the marching Kewties. 2)And now on to numbers, which are primarily used, in both the United States and the European Union, to put children to sleep. In February 2024 there was a seismic change in the number used for the “safe” limit for the particulate matter of 2.5 micrometer size (PM2.5) “safe” ambient (outside) air, both in the United States on 2/9/2024 and the European Union on 2/20/2024. 3a)The United States changed the “safe” PM2.5 limit from 12 to 9 micrgrams per cubic meter for PM2.5 “safe” annually on 2/9/2024. 3b) The European Union changed the “safe” PM2.5 limit from 25 (yes, you read that right, 25) to a mere 10 micrgrams per cubic meter for PM2.5 “safe” annually on 2/20/2024. RAWSEP’s editor is inevitably reminded of the famous artist Charles DeMuth’s modernist painting of 1928 (96 years ago!) titled “I saw the figure 5 in gold” since 5 is the gold standard of an annual PM2.5 “safe” limit, set by the World Health Organization (W H O) in 2021 cut in half from the 2005 limit of 10 micrograms per cubic meter annually, which the United States and the European Union are now struggling to emulate, in order to protect human health and slow climate change, since both human health and climate change are worsened by PM2.5, and Wood burning is 90% PM2.5, particulate matter of 2.5 micrometer size, the perfect size to infiltrate the human lung, setting off a cascade of human health problems and early deaths. Wood burning emits 2.8 times the CO2 and PM2.5 as the fossil fuel coal burning. Wood burning emits 450 times the PM2.5 as the fossil fuel natural gas burning. 3)Within theUnited Kingdom. portraits between 1924 and 1929 as tributes to modern American artists, writers, and performers. Though not a physical likeness, Demuth created this portrait of his friend, the poet and physician William Carlos Williams, using imagery from Williams's poem *The Great Figure*, which evokes the sights and sounds of a fire engine speeding down the street. The intersecting lines, repeated "5," round forms of the numbers, lights, street lamp, and blaring sirens of the red fire engine together infuse the painting with a vibrant, urban energy. Demuth derived the title from the poem, which reads: Among the rain and lights I saw the figure 5 in gold on a red firetruck moving tense unheeded to gong clangs siren howls and wheels rumbling through the dark city.

February 21, 2024. A team of researchers from Atlanta's Emory University (investigated) the effects on people's brains of exposure to the type of fine particulate matter known as PM2.5, particles of less than 2.5 microns in diameter, suspended in the air, and known to penetrate deep into living tissue, including crossing the blood-brain barrier. Traffic-related PM2.5 concentrations are a major source of ambient pollution in Atlanta, and also in urban centers across the planet. The brain tissue of 224 people from Atlanta (was examined). 90% of (the brain tissue donors) had a diagnosis of some form of dementia, (and) had agreed to donate their brains to medical science after their deaths. The team also investigated the traffic-related PM2.5 pollution exposure at subjects' homes in the years leading up to their deaths. The average level of exposure in the year before death was 1.32 micrograms per cubic metre ($\mu\text{g}/\text{m}^3$) and 1.35 $\mu\text{g}/\text{m}^3$ in the three years before death. "We found that donors who lived in areas with high concentrations of traffic-related air pollution exposure, in particular PM2.5 exposure, had higher levels of Alzheimer's disease neuropathology in their brain." There was a positive relationship between exposure to high levels of PM2.5 and levels of amyloid plaques in the brains of the subjects the team examined. They found that people with a 1 $\mu\text{g}/\text{m}^3$ higher PM2.5 exposure in the year before death were nearly twice as likely to have higher levels of amyloid plaques in their brains, while those with higher exposure in the three years before death were 87% more likely to have higher levels of plaques. The team also investigated whether having the main gene variant associated with Alzheimer's disease, ApoE4, had any effect on the relationship between air pollution and signs of Alzheimer's in the brain. "We found that the association between In air pollution and severity of Alzheimer's disease was stronger among those who did not carry an ApoE4 allele, those who did not have that strong genetic risk for Alzheimer disease, Which kind of suggests that environmental exposures like air pollution may explain some of the Alzheimer's risk in people whose risk cannot be explained by genetic risk factor." The findings are published in the 21 February 2024, online issue of *Neurology*[®], the medical journal of the *American Academy of Neurology*.
