Personal refusal to wear masks before COVID vaccines were available is strikingly similar to personal refusal to stop indoor residential wood burning. The scientific facts were there, and there was a clear humanitarian reason to comply with what health authorities knew was the best advice in both instances: 1)wear a mask to protect yourself and others from COVID infection, especially before COVID vaccines were available and 2)stop burning wood in whatever setting, outdoor or indoor. Taking personal responsibility for spreading the deadly COVID disease or taking personal responsibility for stopping air pollution in your own neighborhood and in the yards and homes of near neighbors, air pollution that is proven to cause a myriad of deadly diseases, taking responsibility for both seems like a natural human response. Perhaps people are regimented to obey and to spread disease, by exhortations by politicians in the case of COVID transmittance, or people are regimented to obey and spread air pollution and the resulting diseases, by the exhortations of advertising in the case of indoor residential wood burning. This doesn't say much for the intelligence and compassion of humanity that the average person expects from their fellow man. RAWSEP's editor was reminded of the similarities of 1)not wearing a mask before COVID vaccines and 2)not stopping indoor residential wood burning in the face of numerous scientific studies that show the ill health effects and early deaths imposed on near neighbors of indoor residential wood burners, due to PM2.5 emissions from wood burning that are 2.8 times those of the fossil fuel coal burning and 450 times those of the fossil fuel natural gas burning.
