

Episode 56UOa Wisconsin, Dane County June 8, 2024, For May, the Weekly Average PM2.5 from PurpleAir monitors downloaded every month. 9 micrograms per cubic meter is above EPA NAAQS annual "safe" limits.

35 micrograms per cubic meter is above EPA PM2.5 NAAQS "safe" limits in a 24-hour period. EPA NAAQS is United States Environmental Protection Agency National Ambient Air Quality Standards.

Wood burning emits 90% PM2.5, particulate matter of 2.5 micrometer size, the perfect size to infiltrate the human lung, setting off a cascade of human health problems and early deaths.

Residents Against Wood Smoke Emission Particulatates would like to hand out a PurpleAir PM2.5 monitor to any near neighbor of an inside residential wood burner whose wood smoke infiltrates their yards and sickens them.
