This new version known as Modification No. 3 replaces the previous versions of the NOFO. Modification No. 3 makes two major changes to the NOFO. The first change is to the EPA map used to identify disadvantaged communities so that it now reflects the most recent data in OEJECR’s update of EJScreen. For CCGP applicants’ convenience EPA has created a map called EPA Disadvantaged Community Environmental and Climate Justice Program that merges versions 1.0 and 2.0 of the EPA IRA Disadvantaged Communities Map. New applicants should use this map to identify and describe disadvantaged communities per Appendix A of the NOFO. The second change is to remove the oral presentation component of the Track I Application process to reduce the burden to applicants and expedite the review and selection process to ensure funding benefits disadvantaged communities as quickly as possible. The Community Change Grants Program is still accepting applications through November 21 2024 and EPA encourages applicants to submit applications as soon as they completely meet the NOFO requirements. EPA will be making additional selections on a rolling basis for the remainder of 2024. EPA also encourages interested applicants to apply for technical assistance as soon as possible as the last day to request new technical assistance is August 16 2024. Design values are calculated air quality concentrations used to determine compliance with the National Ambient Air Quality Standards (NAAQS). EPA expects air agencies will rely upon this set of design values to evaluate the impact of the 2023 Canadian wildfires as well as other potential exceptional events and to develop recommendations for whether areas within their jurisdictions meet the strengthened annual PM2.5 standard. These design values incorporate the updated PM2.5 data collected using Teledyne T640/T640X Federal Equivalent Method monitors. Elk Valley RCMP Sgt. Svend Nielsen said officers were patrolling at Lake Koocanusa on the weekend when campers reported that someone had lit a wood-burning fire at their site which goes against current fire restrictions in the Wildfire Act of British Columbia. A ban was issued for category one campfires in Southeast B.C on July 12 which is defined as a fire up to half a meter high and half a meter wide that is used for recreational or ceremonial purposes. Nielsen said the campers had approached the fire maker and explained the current restrictions in B.C but the person had brushed off their concerns so they returned with their own fire extinguisher and put it out themselves. An officer visited the site and issued a fine after they found evidence of the fire. Police advise the public to report fires immediately to 250-425-6233 if they see one.
