Main Content. United States. **RAWSEP View.** Could the Heat Pump Rebates scheduled to roll out across the United States starting in Fall 2024 be clawed back? Probably not. And why would anyone want to claw back Heat Pump Rebates that incentivize clean alternatives to air polluting home heating by antiquated methods like wood burning? But the word Conservative in politics is often roughly analogous to the word Reactionary in politics. The Conservative Right reacts to replacement of wood indoor residential burning along with fossil fuel burning for home heating as an assault of corporate profits rather than as positively building a network of clean alternatives for home heating and contributing incrementally to slowing climate change and most importantly for Residents Against Wood Smoke Emission Particulates protecting the health of near neighbors of indoor residential wood burners whose wood smoke enters the near neighbors' yards and sickens the near neighbors. In Episode 56YQ the examples of beliefs in the United States that might enable clawing back clean alternatives for home heating are expanded on first in 1A an article about the United States history of reacting to public health and weather emergencies so slowly that lives were unnecessarily lost. 1 United States Public Health services stumbled out the gate when COVID 19 hit in early 2020 when they did not forecast to the American public that COVID 19 was a threat early in the pandemic. Public Health services could have emphasized what they did know about how to respond to an airborne threat and did not immediately advise the general public to wear masks. The reason for this lag in helpful communication was to prevent panic. Looking back it would be better to Public Health services to provide as much clarity as possible from the very beginning. How does this relate to the threat of Heat Pump Rebates being clawed back? The Inflation Reduction Act was passed years ago and measures like Heat Pump Rebates are only now in 2024 being rolled out. The need for an alternative to air polluting home heating methods was not clearly communicated out of the gate. It seems that the clarifying incident that caused people to clearly see that wood burning in the form of wildfire smoke that affected most of the United States by June 2023 was the catalyst for Public Health services to finally advise that people exposed to high levels of wood smoke stay in their sealed homes with multiple air purifiers running. COVID 19 clear advice that could have saved more lives if implemented earlier was to wear masks. Indoor residential wood burning smoke and the identical wood burning smoke of wildfires clear advice in June 2023 that could have saved more lives if implemented earlier was to stay inside sealed homes with multiple air purifiers running. Secondly 1B The Environmental Protection Agency EPA in late September responded to an August 2023 lawsuit from 10 Assistant Attorney Generals asking the EPA to act to improve the New Source Performance Standards for Indoor Residential Wood Stoves which the EPA was required to do every 5 years. The EPA kicked the can down the road to 2027. This was foreshadowed in the Spring of 2023 even before the lawsuit began when the EPA responded to complaints on delay by stating that no changes could be made before 2027. The EPA was true to their word and dragged their feet as promised. Is there another way to deal with the predictable air pollution of indoor residential wood burning? Residents Against Wood Smoke Emission Particulates suggested in letters to the 10 Assistant Attorney Generals and to Doctor Jeanne Marrazzo who succeeded Doctor Anthony Fauci that a parallel track to solve the problem of air pollution caused by indoor residential wood

burners be implemented, similar to the parallel track Dr. Anthony Fauci implemented in 1989. In 1989 Dr. Fauci followed the parallel track of offering AZT the anti-AIDS drug allowed for clinical trials which had the unfortunate side effect of causing blindness along with Ganciclovir which cured the side effect of blindness although Ganciclovir was not officially approved by the FDA to be used in the AZT clinical trials until parallel track was approved by the FDA at the insistence of Dr. Fauci. Similarly if the EPA is mired in a failed program of wood stove certification until 2027 that allows highly polluting wood stoves to continue to be approved as safe until 2027 then this will have the unfortunate side effect of adverse health effects and early deaths for near neighbors of indoor residential wood burners. In 2024 Dr. Marrazzo could follow the parallel track of not interfering with the EPA certification of highly polluting indoor residential wood burners as safe (although there is no scientific reason for this flawed program to continue) and also allow some federal government agency like the Department of Health to allow shutdown of indoor residential wood burning stoves whose PM2.5 emissions are proven to enter the yards of near neighbors and sicken the near neighbors. PurpleAir PM2.5 monitors hanging from the eaves of the houses of near neighbors of indoor residential wood burners could prove that PM2.5 emissions above World Health Organization standards of 5 micrograms per cubic meter annually entered the near neighbors yards, and this evidence could be the standard of shutting down indoor residential wood burning one wood burning stove at a time if necessary. Thirdly 1C The clawing back of Heat Pump Rebates by reactionaries. Those not busy being born are busy dying. Residents Against Wood Smoke Emission Particulates if getting a little impatient about the rollout of Heat Pump Rebates. There are many stories being written about the benefits and the future use of Heat Pump Rebates but it hasn't happened yet. There are reactionaries waiting in the wings hoping that the November 5 election will vault them in majorities in the House and or Senate and vault Republicans into the Presidency and Vice Presidency. It could happen and then the reactionary claw back of Heat Pump Rebates could begin, which would dampen the hopes of Residents Against Wood Smoke Emission Particulates for the perfect carrot to offer to indoor residential wood burners who claim they are indigent. This is a cautionary prediction that if the elections are not won on several different levels we might end up further from breathing clean air and living on a more slowly warming planet. Maybe contemplating this will make us work harder to ensure that the future is as bright as we hope it will be. 1A United States. New York Times. Want People to Embrace Public Health? Oct. 2 2024. The author of this New York Times article is an epidemiologist. In 1925 a tornado cut a track hundreds of miles long flattening schools and houses across three Midwestern states. At points the storm was nearly a mile wide and appeared to observers not as a thin funnel but as a wall of angry clouds. Nearly 700 people lost their lives making it the deadliest tornado in U.S. history. The tragedy was compounded by an astounding error of human judgment. At the time it was taboo for weather scientists to forecast tornadoes in public communication. Experts feared that such a warning would cause unnecessary disruption or panic if the tornado didn't materialize. Residents in the path of the tornado were caught by surprise. The justifications for this prohibition may sound familiar to those who remember the early days of the Covid19 pandemic when senior health officials repeatedly assured that risk to the American public was low. One skeptic of the weather community's duty to warn of tornadoes argued that the stoppage of business and the unnecessary fright would be worse than the storms themselves. A desire to prevent panic predominated as it too often does in the case of outbreaks. Public health officials can learn from how the weather

community corrected these mistakes. Today a prohibition on storm warnings would be unthinkable. Public health communications often take a different approach choosing conservatism over a duty to warn. Some public health experts fear crying wolf when it comes to uncertain threats. This is a mistake. Deciding whether when and how to communicate about public health risks is tricky. Outbreaks are fastmoving complex and difficult to predict. The rise of misinformation and eroding trust in public health makes effective messaging even harder. No communication plan will be above reproach. Still this is a unique moment in history to shift public health's approach to communication. Historically one point of departure between weather and public health was personal experience. Most Floridians have lived through a hurricane and most Nebraskans know tornadoes. But until the Covid19 pandemic few Americans had experienced a disease outbreak so widespread and severe. That has now changed and more people are tuning in. The public health community must capitalize on this new awareness by embracing the public as partners in health preparedness and response. Just as the weather community evolved to prioritize messaging so too should public health. The job of public health experts is to give people clear guidance about what they will face and how they can protect themselves. That does not include a special mandate to prevent panic or stigma when doing so sacrifices clarity. But the two freshman Republicans have voted reliably with the House GOP majority to undo efforts to cut greenhouse gas pollution and accelerate the transition to renewable

power and electric vehicles. And they are strong supporters of former President Donald Trump who has endorsed both candidates and promised to deliver a fatal blow to existing climate policy if reelected. The two representatives are among a group of GOP members whom environmental advocates are targeting as they work to flip the House of Representatives back to Democratic control. The activists view the congressional races and electing Vice President Kamala Harris to the presidency as equally crucial for preserving and extending the historic climate progress made during President Joe Biden's term. They have set their sights on Republicans who were narrowly elected in 2022 and face tough reelection battles in swing or Democratic leaning districts this November. Voicing concern over climate change is one way vulnerable GOP members have broken from their party's mainstream to appeal to voters across the political spectrum especially in districts that have been battered by extreme weather and fire. Environmental groups are working in the districts to deliver the message that these Republican members' actions belie their words on climate change. They're addressing it now because their constituents are asking them about it and are feeling the pain of the results of manmade climate change. They're paying lip service to dealing with the everyday impacts of climate change while not actually addressing the root cause of it in a meaningful way. Environmental activists believe Democratic control of the House at least would serve as a firewall to protect much of the climate progress that has been made under Biden if in what they see as a worst case scenario Trump wins and Republicans capture control of the Senate. Nearly all Republican House incumbents have voted multiple times to repeal the clean energy provisions of Biden's landmark climate legislation the Inflation Reduction Act. We're now seeing some Republicans saying Let's take a scalpel to the IRA repeal and trying to greenwash themselves even though they've voted multiple times to repeal these tax credits said the vice president for political affairs for the League of Conservation Voters. Oil and gas industry spending on the 2024 election has already hit a record \$147 million with 89 percent going to Republicans. The lopsided giving is mirrored in the polarization over climate policy in Congress and a GOP led House that is trying to undo the progress of the past four years environmental activists say. For decades West Virginia has elected senators who have played an oversized role in United States energy policy backing fossil fuels and resisting robust action on climate change. The West Virginia Senate race could radically change West Virginia's role as the state limiting the ambitions of national climate policy. The nation's No. 2 coal state

could elect a full throated fossil fuel boosting senator in November in fact coal operator and businessman Jim Justice the current Republican governor and an acolyte of former President Donald Trump is running more than 30 points ahead in the latest June 2024 polls. Justice 73 would just add to what is now essentially the unanimous pro fossil fuel bloc of Republicans in Congress. His Democratic opponent Glenn Elliott 52 an attorney and mayor of Wheeling sits firmly in the mainstream of his party on climate change. Elliott argues that warming is bringing dangerous weather extremes like torrential downpours to West Virginia and that an energy transition away from fossil fuels is inevitable. The 2024 Senate race also ends West Virginia's long reign at the fulcrum of that policy with the balance in the Senate often tipped by Manchin over his 14 years in Washington and for more than 50 years prior by his predecessor the late Sen. Robert Byrd. In a speech two years ago Justice downplayed renewable wind and solar power and stated oil gas and coal are the meat and potatoes. Of climate change Justice said I don't know if it's for real or not. In backing coal he went on to play the religion card while ignoring the economic reality of coal losing its competitive edge to natural gas and renewable energy. For his part Mayor Elliott said in an interview that The market itself is going to steer us away from a fossil fuel based energy production model and we need to be doing something to prepare for that reality instead of just doubling down on the way we've done things. In 1997 then West Virginia Senator Byrd by then former Senate Majority Leader reached across the aisle to join with Nebraska Republican Sen. Chuck Hagel to author and secure a unanimous resolution opposing the United Nations climate agreement known as the Kyoto Protocol effectively blocking U.S. ratification of the treaty. Another significant Byrd moment came 10 years later when the Senate was debating what eventually became the Energy Independence and Security Act of 2007. The Democrats had full control of Congress for the first time since 1993 with the Senate essentially evenly split as it is today. It was the Democrats' big chance to address climate change. The legislation that President George H.W. Bush ultimately signed improved fuel economy and supported biofuels and energy efficiency. But mainly because of Byrd and other Democratic moderates at the time the Senate jettisoned the House passed effort to establish a National Renewable Energy Portfolio standard like those that were becoming popular at the state level. The proposal was for 15 percent of U.S. power to come from clean energy. While the Inflation Reduction Act invests \$370 billion in fighting climate change more federal dollars than any other federal action West Virginia Senator Manchin made sure the legislation included items that bolstered the fossil fuel industry such as a requirement that the U.S. government offer millions of acres of federal land for new oil and gas leasing over the next decade. Some environmental critics decried the fossil fuel support with one calling the comprises climate suicide West Virginia Governor Jim Justice spoke next to President Donald Trump at a campaign rally in Huntington West Virginia on Aug. 3 2017. Justice earned the endorsement of the West Virginia Manufacturers Association in part because of the governor's views on energy production. Formerly on the Forbes billionaire list Justice inherited a fortune in coal interests from his father and his family's companies have faced and continue to confront a staggering trail of lawsuits debt and environmental health and safety fines. Justice is right at the forefront of those who wink and nod at mine safety and environmental regulation. Justice's opponent Mayor Elliott said his campaign intends to show how Justice hasn't had to play by the same rules as everyone else. Elliott is a Wheeling native has degrees from the University of Pennsylvania's Wharton School of Business and Georgetown University's law school. He's been mayor of the state's third largest city since 2016. Democrat Elliott touts women's health issues and reproductive choice.. Regarding energy Elliott said he recognizes the role that West

Virginia coal has played in the economy of the state and nation but coal has also come at great cost. It's killed a lot of miners either directly in the mines or it has sickened miners after the fact. It's damaged a lot of communities. Elliot said that it's important for West Virginia's senator to advocate that if we're going to be moving away from these fossil fuels that we've always relied on West Virginia needs to make sure we get made whole in that equation.
