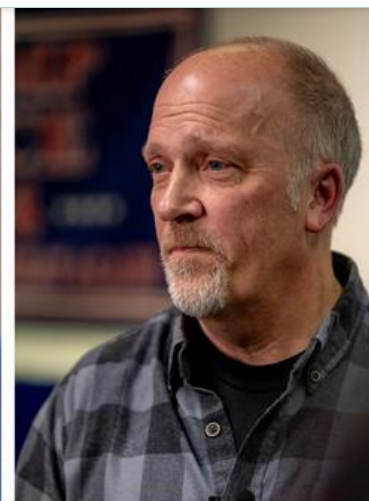

1 United States Trump Administration Has Begun a War on Science Researchers Say Nearly 2000 scientists urged that Congress restore funding to federal agencies decimated by recent cuts [Excerpts edited by RAWSEP for brevity and clarity and relationship to Residents Against Wood Smoke Emission Particulates a 501c3 nonprofit organization](#) The New York Times March 31 2025 Some 1900 leading researchers accused the Trump administration in an open letter on Monday of conducting a wholesale assault on US science that could set back research by decades and that threatens the health and safety of Americans The signatories all of them elected members of the National Academies of Sciences Engineering and Medicine warned of the damage being done by layoffs at health and science agencies and cuts and delays to funding that has historically supported research inside the government and across American universities For over 80 years wise investments by the US government have built up the research enterprise making it the envy of the world the letter said Astoundingly Trump is destabilizing this enterprise by gutting funding for research firing thousands of scientists removing public access to scientific data and pressuring researchers to alter or abandon their work on ideological grounds

Thumbnail of page 1 Read the Letter Researchers at academic institutions nationwide say that US science is being dismantled The letter said that many universities and research institutions had so far kept silent to avoid antagonizing the administration and jeopardizing their funding But it said the United States scientific enterprise is being decimated The signatories called on Americans to appeal to Congress to protect scientific funding With Musk efforts to cut spending and the Trump crackdown on institutions he sees as ideological enemies the administration has sought to dismantle parts of the federal scientific funding apparatus Funding from the National Institutes of Health which supports work by more than 300000 scientists across the country has fallen billions of dollars short of typical levels during the early months of Trump The White House has also moved to cancel research in specific areas like transgender health and climate science Trump announced last week that it was laying off 10000 employees at the Health and Human Services Department as part of a broad reorganization that reflected the priorities of the health secretary Robert F Kennedy Jr The department has hired a discredited vaccine skeptic to research a link long debunked by scientists between vaccines and autism On Friday the United States top vaccine regulator resigned citing misinformation and lies of Kennedy In recent weeks members of the National Academy of Medicine a nonprofit organization that provides independent health policy advice began discussing their concerns with members of the national academies of sciences and engineering Those conversations gave rise to the open letter said a male medical doctor who is an organizer of the letter who studies health policy at Virginia Commonwealth University The letter was drafted by a group of 13 scientists representing fields like medicine climate science sociology and economics I know what this is going to do to life expectancy in the United States to mortality rates to the mental health crisis we are having he said These changes in the research enterprise are going to translate into harms to everyday Americans He cited for example the planned restructuring of the Agency for Healthcare Research and Quality a small agency charged with protecting patient safety and guaranteeing Americans access to free preventive services like mammograms The agency responsible for protecting the quality of health care in the United States just got demolished he said The letter outlines the consequences of funding cuts including pauses on research studies faculty layoffs and reduced graduate student enrollments It also accuses the administration of engaging in censorship by among other things

11 California In Southern California a Sea Mammal Crisis Washes Ashore In recent weeks hundreds of sea lions dolphins and other animals have turned up in the sand dead or seriously ill alarming rescuers and beachgoers alike [RAWSEP View](#) The cause is domoic acid [Excerpts edited by RAWSEP for brevity and clarity and relationship to Residents Against Wood Smoke Emission Particulates a 501c3 nonprofit organization](#) The New York Times March 31 2025 A man who works for a sea mammal rescue group rushed to help save the animals and transport them to get treated Both sea lions were given ID numbers which told a story They were tagged as 25 193 and 25 195 the 193rd and 195th patients of the group for the year All along the Southern California coastline from San Diego to Santa Barbara hundreds of animals sea lions dolphins seabirds are washing up on the sand either dead or seriously ill The cause is a neurotoxin produced by an algae bloom The toxin known as domoic acid is harmless to fish but can be deadly to sea mammals Fish carry the toxin but if mammals and birds eat the fish the toxin can poison them causing seizures making them behave erratically or putting them in a coma The only treatment is to flush out the toxin and medicate the symptoms Coastal researchers and officials say it is become a marine life crisis that has overwhelmed rescue organizations distressed beachgoers and hurt the ocean habitat of California Algal blooms are not rare in California but the amount of toxic acid the blooms have been releasing and the scale of harm they have been causing to sea life have puzzled scientists Some say it has to do with climate change and warming sea temperatures Others say the nutrients in the runoff from land can stimulate algae blooms Scientists with the National Oceanic and Atmospheric Administration are studying whether the washed out ash and debris from the Los Angeles wildfires in January may have influenced the current bloom More research is needed to understand the changing blooms is largely funded by NOAA and has come under threat The Sea lions have a 60 percent chance of survival from the toxin At the rescue center veterinarians examined both animals Both sea lions have a good chance of surviving Throughout the weekend they were stable and resting Eventually they gained some identity too They were 25 193 and 25 195 no more Now they are Carlin and Kelley

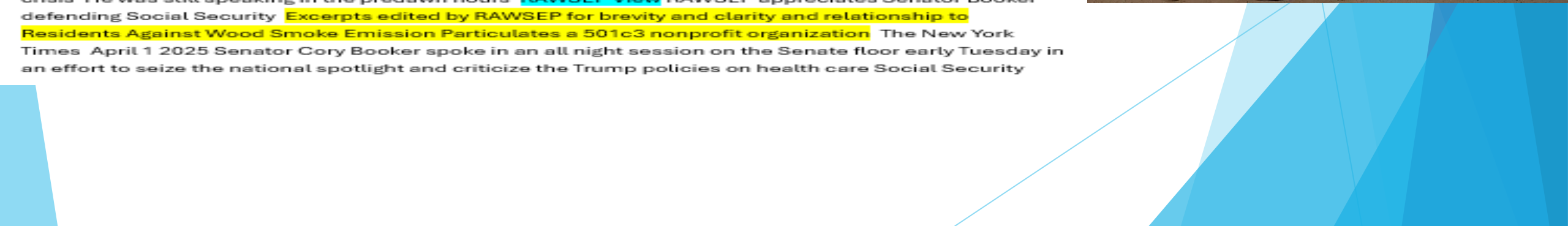

education and much else Booker Democrat of New Jersey began speaking on Monday evening and said he planned to continue for as long as he was physically able He was still going as of 5 am Eastern time The speech focused in part on what Senator Booker said were Trump plans to cut funding for Medicaid among other programs The White House has denied that it plans to cut Medicaid benefits but the president and his allies have attacked Medicaid Medicare and **Social Security** over what they claim is waste fraud and abuse I rise with the intention of disrupting the normal business of the United States Senate for as long as I am physically able Senator Booker said near the start of his speech I rise tonight because I believe sincerely that our nation is in crisis stopped speaking to allow questions from fellow Democrats including Senator Chris Murphy of Connecticut without formally relinquishing the floor His speech was not a filibuster because it did not come during a debate over a specific bill or nominee But it could still disrupt official business if it continues past noon when the Senate is scheduled to convene Before his speech Senator Booker said on social media that he was heading to the Senate floor because Trump and Musk had shown what he called a complete disregard for the rule of law **These are not normal times in America** Senator Booker said the Musk feed on X his social media platform was active late into the night but it made no mention of Senator Booker or his all night speech Neither did the Trump Truth Social feed Viewers followed along on **the official Youtube Channel of Senator Booker** With dawn about an hour away Senator Booker a onetime presidential candidate looked full of energy as he read from papers on his lectern in a booming voice But the length of his session at 10 hours and counting was not close to making Senate history

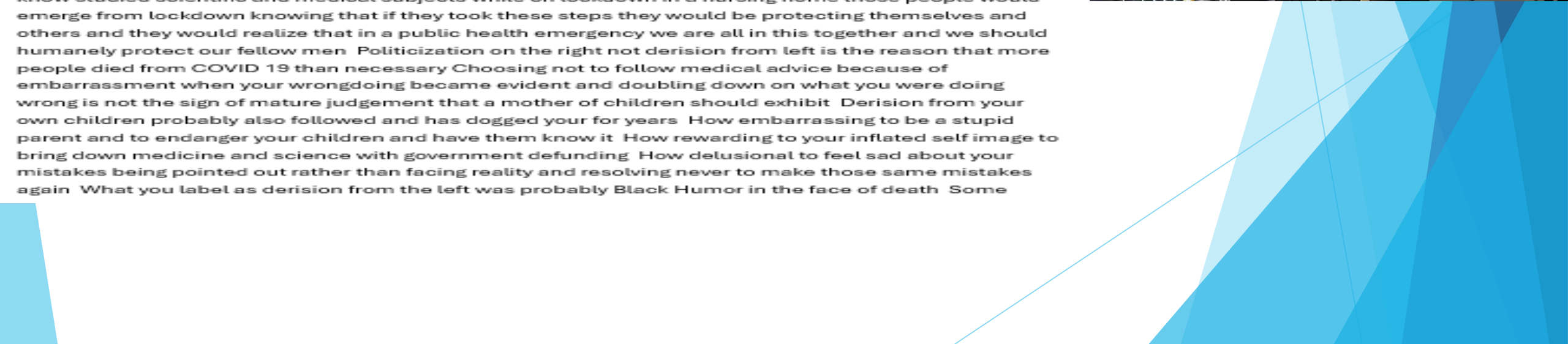

homes and children struggled through online school. By late spring 2020 we had discovered one of the few mercies of Covid: Children were not commonly succumbing to the disease. I started publicly calling for them to return to school in person that summer. Outside of my local community where most people seemed to agree with me, the backlash was swift and cruel. Like many other dissenters, I was accused of denying science and lacking concern for humanity. Authorities I would trust to tell me when to vaccinate my children for measles and polio also said a cheap cloth mask from Old Navy could help protect them from microscopic pathogens. It made no sense yet expressing doubts about following the science was treated as sacrilegious.
