

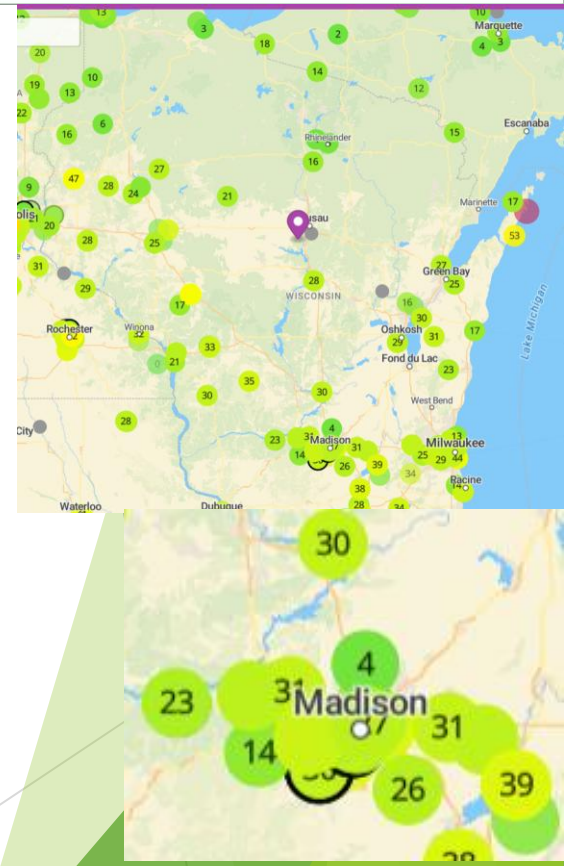

35 micrograms per cubic meter is above EPA PM2.5 NAAQS safe limits in a 24 hour period EPA NAAQS is United States Environmental Protection Agency National Ambient Air Quality Standards

World Health Organization W H O annual safe limits is 5 micrograms per cubic meter The formula PA times 1.8304 is what the Wisconsin Department of Environmental Protection uses to smooth out PurpleAir data on maps

Wood burning emits 90% PM2.5 particulate matter of 2.5 micrometer size, the perfect size to infiltrate the human lung setting off a cascade of human health problems and early deaths

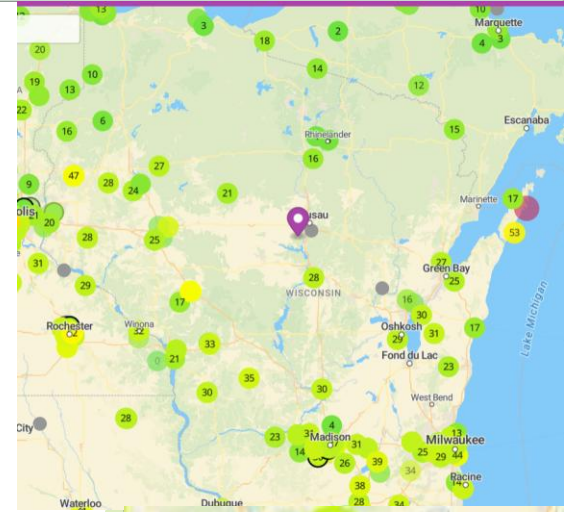
