1A RFK Junior removes all 17 members of the CDC vaccine advisory committee [Excerpts edited by RAWSEP for brevity and clarity and relationship to Residents Against Wood Smoke Emission Particulates a 501c3 nonprofit organization](#) ABC News June 9 2025 The committee makes recommendations on the safety and efficacy of vaccines Removal of CDC panel undermines value of vaccines A Doctor who is a senior scholar at Johns Hopkins University says Health and Human Services Secretary Kennedy Junior action makes the U S less prepared for infectious disease threats The CDC has published a list of conflicts of interest declarations disclosed by voting members during public meetings since 2000 Kennedy also wrote that ACIP had never recommended against a vaccine even those later withdrawn for safety reasons In fact members ACIP have at times recommended a narrower use of a vaccine than what was technically allowed by authorization from the Food and Drug Administration FDA Kennedy had previously claimed he would not touch ACIP A pediatrician specializing in infectious diseases and a member of the FDA independent panel of vaccine advisers said Kennedy does not have a single example to show where a vote by one of these committees has hurt children In fact the opposite is true The votes by this committee over the last 25 years have caused children to suffer less and die less ACIP should be given awards not fired Many major health advocacy organizations also pushed back on the move Last week a CDC official who co led a part of ACIP announced she was resigning following the Kennedy announcement on changing COVID 19 vaccine recommendations MORE RFK Junior has promoted freedom of choice while limiting vaccines and limiting food choices
