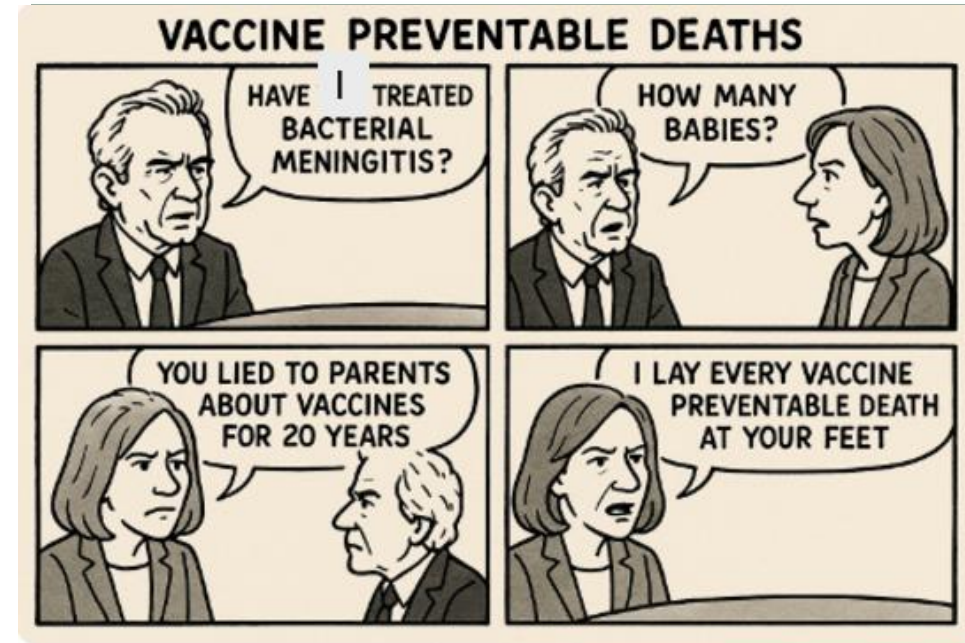
**RAWSEP View** Robert F Kennedy Junior is our Health and Human Services Secretary He is not a physician and has not studied medicine at any college or university His name recognition as a son of a famous Democratic politician and the money from his family connections is apparently the key to his success in getting on the ballot in the presidential race in 2024 and getting picked by Trump to take on this highly responsible position In a way RFK Junior is like the common man or woman in the United States or like the majority of people in the United States because he is not a physician and has not formally studied medicine However RFK Junior took extraordinary steps to put himself forward both as a presidential candidate and as a Health and Human Services Secretary and answered questions before Congress about his new role as HHS Secretary There is a public record of his responses to questions about his competency to do his job and about the effects already in 5 short months of his shirking of his responsibility to protect Public Health while carrying out incompetently what is normally expected of a functioning Health and Human Services Secretary acting in response to the health needs of the public Being a physician a nurse an emergency medical technician a pharmacist a scientific researcher or a medical researcher requires demonstration of competence to begin with and requires demonstration of ongoing responsible actions while carrying out each particular job that impacts Public Health Those competencies are usually a medical or medical related education testing every couple of years or yearly on knowledge of new developments in the field and ongoing overview by government regulation and licensing of activities that impact Public Health to show that actions being taken by the individual are responsible and concerned with maintaining Public Health If someone is not trained or working in a Public Health related field those majority of Americans may feel excluded from medical decision making when a professional takes over when they are sick and usually only suggests or in an emergency even directs the average American to take some action to preserve their own health or life In an emergency the Health Care professional might suggest that the average American take a vaccine for example since the alternative of not taking a vaccine would put that person and anyone that person comes in contact with at risk of death or severe disability The American of average intelligence knows this RFK Junior times during public speaking mimes having hearing issues and he has a complex and unusually impeding vocal problem that might be solved by a using a vocoder like the vocalist Cher or using the vocoder to simulate the effects of cochlear implants or through at least three options normally used for restoring the voice after a laryngectomy 1 Tracheoesophageal Voice Prosthesis 2 Electrolarynx or 3 Esophageal Speech From the article Voice Restoration for Laryngeal Cancer Excerpts edited by RAWSEP for brevity and clarity and relationship to Residents Against Wood Smoke Emission Particulates a 501c3 nonprofit organization New York University website Doctors and speech and swallowing therapists provide several options for restoring the voice after a laryngectomy which is the full removal of the larynx or voice box to manage laryngeal cancer These options include a voice prosthesis esophageal voicing and an artificial larynx also known as an electrolarynx Voice restoration is usually provided after all treatments for laryngeal cancer are complete These procedures typically are not necessary in people with early laryngeal cancer 1 Tracheoesophageal Voice Prosthesis To restore speaking ability in

people who have had a laryngectomy This usually provides the best voice quality compared to other voice restoration methods At the time of laryngectomy or during a separate surgery surgeons insert a prosthesis a small valve like device into the upper part of the trachea and connect it to the adjacent esophagus the muscular tube that carries food from the mouth to the stomach To speak a person takes a breath covers a stoma a small surgically created opening from the trachea that leads to the outside of the neck with a finger or a small plastic valve and exhales This causes air to flow through the prosthesis into the esophagus This airflow makes the top of the esophagus vibrate creating sound that the mouth shapes into words The voice produced has a generally rough hoarse quality This method of voice production cannot begin until the surgical incisions are well healed Speech therapist can help you learn how to speak using a voice prosthesis

2 Electrolarynx Another voice restoration option is an artificial larynx also known as an electrolarynx This small battery operated device is placed directly on the neck under the chin when you want to speak When you push a button on the device the electrolarynx produces a vibration that is transferred through the skin to the throat You shape this sound into words with the mouth tongue lips and teeth The sound created by an electrolarynx has an electronic quality but it can be well understood Speech therapists can teach you how to use the device as a primary means of communication or as a backup to one of the other options

3 Esophageal Speech Esophageal speech involves learning to push air with the mouth into the esophagus and then back out again causing the upper esophagus to vibrate and make a sound This sound is shaped into words by the mouth lips tongue and teeth Esophageal speech usually creates a rough hoarse sound This method does not require additional surgery or devices but learning how to produce esophageal speech takes practice The editor of RAWSEP believes that Vocoders are available to anyone with enough money Obtaining a prosthesis or artificial larynx or speech therapy costs money but also necessitates the intervention of health care professionals to install prostheses or artificial larynxes or to train the average American to push air with the mouth into the esophagus then then back out again RFK Junior has not demonstrated the minimal competency required of any working Public Health worker in the areas of scientific and medical knowledge or knowledge of a specific Public Health field as shown by his answers to questions during public hearings RFK Junior has not taken steps available to him as a man of wealth to obtain widely available solutions to his vocal problem that impedes understanding of his words during public hearings In the last public hearing RFK Junior also demonstrated inability to understand simple words of other people when they asked him questions It was necessary for RFK Junior to understand the questions from medical professionals in order to demonstrate his competence in the job of Health and Human Services Secretary RFK Junior failed in demonstrating minimal competence to do his job very recently in an interaction he had with Steier Here are parts of that exchange to demonstrate the point of RFK Junior Incompetence This exchange also demonstrates the uncaring and irresponsible attitude of RFK Junior to the points that Schrier is making about the importance of vaccines in preventing illness and in many cases unnecessary death Transcript from the video titled Kim Schrier says RFK Junior should be held responsible for every death from a vaccine preventable illness United States Representative Kim Schrier who is a former physician a Democrat from Washington and co chair of the Congressional Doctors Caucus confronted Health and Human Services Secretary Robert F Kennedy Junior in a public hearing over his decision to replace a panel of vaccine experts who make key recommendations RFK Junior replaced those medical experts At issue is the Advisory Committee for Immunization Practices with acronym C I P which makes recommendations on the safety efficacy and



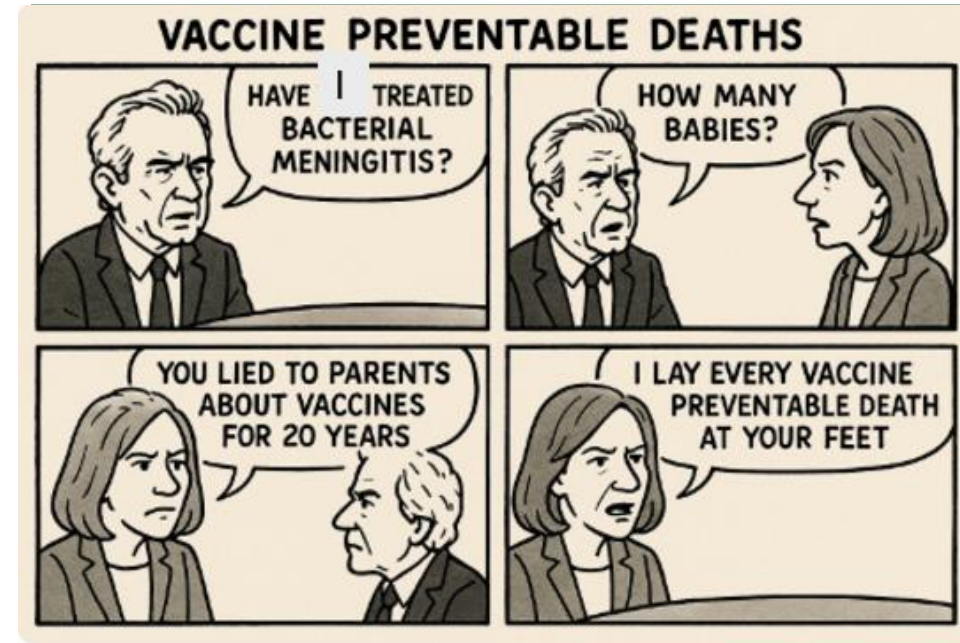

clinical need of vaccines to the Centers for Disease Control and Prevention the C D C The C I P formerly was comprised of medical and public health experts who develop recommendations on the use of vaccines in the civilian population of the United States The demonstrably incompetent vaccine skeptics who replaced the previous CIP panel in their June meeting did not take up the issue of Covid 19 Vaccines as has normally been done since the Covid pandemic began in 2020 Not discussing Covid 19 Vaccines effectively delays new updated Covid Vaccines from being available this fall in a timely manner

RFK Junior answered incompetently and not just incompetently as a layman without medical knowledge but incompetently because he expressed irritation at even being asked questions which required medical knowledge to answer or required at least knowledge of the Public Health care and attention needed for children sick with Measles Mumps and Pertussis also known as Whooping Cough In one instance he restated a question he appeared unable to hear although everyone at the hearing and all viewers of the video with ordinary intelligence and layman knowledge of illness and ordinary concern for sick children would find all the questions easy to understand After asking if RFK Junior had treated sick children for common childhood diseases Kim Schrier explained briefly the illnesses and unnecessary deaths that happened to children under her watch as a physician when those children were denied vaccines in time to help them The less than 5 minute exchange ended with Kim Schrier saying that because of his replacement of competent medical professionals with demonstrably incompetent vaccine skeptics on the CIP panel Schrier said RFK Junior should be held responsible for every death from a vaccine preventable illness The editor of RAWSEP believes that knowingly causing the death of innocent individuals is one definition of evil The editor of RAWSEP believes those actions justified in a public voice that is deliberately periodically incomprehensible without treatment is an example of Doing evil while pretending to be incompetent Going back to the exchange in Congress The Kennedy Junior answers of Do I what? and Excuse me? after questions were posed loudly and clearly to all but RFK Junior were seemingly intended to show low intelligence and low competence to begin with and a careless yet deliberate disregard for any medical knowledge throughout the hearing How many babies? RFK Junior replied to a question about whether he has treated spinal meningitis shows the ongoing RFK Junior inattention or uncaring attitude to public proceedings His replies did not demonstrate a simple hearing problem The next exchange showed the RFK Junior motivation to deliberately do harm to the health of others When Kim Schrier asked RFK Junior if he RFK Junior lied when he told Senator Bill Cassidy of Louisiana that he would not change the CIP panel of experts if Cassidy confirmed RFK Junior as HHS Secretary RFK Junior answered I never made that agreement I did not see that statement by Senator Cassidy that I promised not to change the panel I only heard it from you Kim Schrier but if Bill Cassidy said that I agreed to keep the CIP panel of experts it would be inaccurate Kim Schrier ended the exchange by saying that for most of us sitting here right now we believe Senator Cassidy more than we trust you when it comes to vaccinations Kennedy replied I am complying with all the agreements Kim Schrier replied You are now on the record You lied to Senator Cassidy You have lied to the American people You lied to parents about vaccines for 20 years and I also want to make it clear that I will lay all responsibility for every death for a vaccine preventable illness at your feet I yield back
